**LABOUR RELATIONS ACT, 1995****BARGAINING COUNCIL FOR THE MEAT TRADE, GAUTENG:  
EXTENSION OF AMENDMENT OF MAIN COLLECTIVE AGREEMENT TO  
NON-PARTIES**

I, **THEMBELANI WALTERMADE NXESI**, Minister of Employment and Labour, hereby in terms of section 32(2) of the Labour Relations Act, 1995, declare that the Collective Agreement which appears in the Schedule hereto which was concluded in the **Bargaining Council for the Meat Trade, Gauteng**, and is binding in terms of section 31 of the Labour Relations Act, 1995, on the parties which concluded the Agreement, shall be binding on the other employers and employees in that Industry, with effect from the second Monday after the date of publication of this Notice and for the period ending 30 June 2026.

made and entered into, in accordance with the provisions of the Labour Relations Act, 1995, as amended, between the

**Meat Traders Association Gauteng**

(hereinafter referred to as the "employers" or "employers' organisation"), of the one part, and

**Meat and Allied Workers Union**

**Gauteng Meat Traders Employees' Union**

(hereinafter referred to as the "employees" or the "trade unions") of the other part,

being the parties to the Bargaining Council for the Meat Trade Gauteng to amend the agreement published under Government Notice R643 of 07 July 2017.

**1. SCOPE OF APPLICATION OF AGREEMENT**

- (1) The terms of this Agreement shall be observed in the Meat Trade in the following Magisterial Districts:
- Alberton, Boksburg, Braakpan, Germiston, Kempton Park, Johannesburg, Randburg, Roodepoort, Benoni, Krugersdorp, Randfontein, Springs, Westonaria and the area within a 25 km radius of Church Square, Pretoria -
- (a) by all employers who are members of the employers' organization and by all
- (b) employees who are members of the trade unions, and who are engaged or employed in the Meat Trade.
- (2) Notwithstanding the provisions of subclause (1), the terms of this Agreement shall apply only in respect of employees for whom wages are prescribed in this Agreement.
- (3) The provisions of clauses 1(1)(a) and (b), and 1A of this Agreement shall not be binding on non-parties.

**1A. PERIOD OF OPERATION**

This Agreement shall come into operation on such a date fixed by the Minister of Labour in terms of section 32 of the Labour Relations Act, 1995, as amended, and shall remain in force until 30 June 2026.



**2. CLAUSE 3: REMUNERATION**

Substitute the following for clause 3:

**"3. REMUNERATION**

- "(1) As from the date of coming into operation of this Agreement, no employer shall pay and no employees shall accept wages lower than the following: -

Admin/Office Assistant .....	7938.96
Cashier .....	5655.00
Butchery Assistant .....	5278.24
Shop Assistant .....	5089.10
Manager .....	13037.72
Master meat cutting technician, grade IA.....	12080.80
Meat cutting technician, grade IB.....	10503.16
Meat cutting technician, II .....	8630.00
Driver .....	5407.20
Security Officer .....	5407.20
Area Manager .....	21219.34

- (2) Differential rates - An employer who requires or permits an employee of one category to perform the duties of a higher paid category for longer than one hour in any one day, either in addition to his own work or in substitution thereof, shall pay such employee in respect of that day, not less than one sixth of the higher weekly wage prescribed in subclause (1)."

**3. CLAUSE 22. COUNCIL FUNDS**

Insert the following:

**CLAUSE 22B. TRAINING FUND OF THE EMPLOYERS' ORGANISATION**

- "(1) Every employer shall, in respect of each establishment he owns or conducts, pay a monthly levy of R150.00 to the Council, which will be utilized by the employers' organisation towards the Employers Organisation's Training Scheme.
- (2) The Council shall each month pay over to the employers' organisation all moneys paid to the Council in terms of subclause (1) above, less a collection fee which shall be determined from time to time by the Council on gross collections, which amount shall accrue to the general funds of the Council."
